AMENDMENT #1

THIS AMENDMENT #1, hereinafter referred to as the "AMENDMENT", entered into between Ryman, Inc. dba Complete Technology Solutions, hereinafter referred to as "CTS", "CONTRACTOR", or "VENDOR" and the South Florida Workforce Investment Board, hereinafter referred to as the "SFWIB", amends the Software License Agreement entered between the parties on July 1, 2017. The Software License Agreement and this Amendment are hereinafter collectively referred to as the "AGREEMENT", between the SFWIB and the CONTRACTOR dated July 1, 2017 and expiring June 30, 2018 to provide Software License.

Page 3, Term, Part 17, is deleted in its entirety and replaced with the following language:

Upon the SFWIB's acceptance of equipment, the term of this Agreement shall commence upon **July** 1, 2017 and terminate at the close of business on **June 30, 2019**, irrespective of its date of execution.

Page 3, Term, Part 18, is deleted in its entirety and replaced with the following language:

The SFWIB may, in the SFWIB's sole discretion, renew this Agreement for up to one (1) additional one (1) year performance period contingent upon satisfactory performance and availability of funding to the SFWIB upon such terms and conditions as agreed to by both Parties in writing.

Page 12, Annual Certification, Part 46, is hereby added as follows:

On an annual basis, the Contractor shall sign the certification that all certifications and assurances set forth in Part 43 sections A through H of the original AGREEMENT are current and that the terms and conditions have not changed. The Contractor shall complete **Exhibit A, Annual Certification,** attached hereto and incorporated herein by reference.

All provisions in the AGREEMENT and any attachments thereto in conflict with this AMENDMENT shall be and hereby are changed to conform with this AMENDMENT.

All other terms and conditions not in conflict with this AMENDMENT remain unchanged as agreed to in the original AGREEMENT.
