SOFTWARE LICENSE AGREEMENT

AMENDMENT #1

THIS AMENDMENT #1, hereinafter referred to as the "AMENDMENT", entered into between Ryman, Inc., d/b/a Complete Technology Solutions, hereinafter referred to as the "CONTRACTOR", and the South Florida Workforce Investment Board, hereinafter referred to as the "SFWIB", amends the Software License Agreement entered between the parties on July 1, 2023. The Software License Agreement and this Amendment are hereinafter collectively referred to as the "AGREEMENT", between the SFWIB and the CONTRACTOR dated July 1, 2023 and expiring June 30, 2025.

License Fee, provision 9. shall continue in its entirety without change as follows:

9. The license fee for this Agreement will consist of an annual maintenance, update and support fee of \$93,972.00 USD, which will be billed at \$7,831.00 per month.

Term, provisions 17. and 18. are hereby deleted in their entirety and replaced with the following language:

17. Upon the SFWIB's acceptance of equipment, the term of this Agreement will commence on July 1, 2023, irrespective of the date of execution, and terminate at the close of business on June 30, 2025, unless earlier terminated as provided below.
18. The SFWIB may, in the SFWIB's sole discretion, renew this Agreement for up to one additional one (1) year period contingent upon satisfactory performance and availability of funding to the SFWIB upon such terms and conditions as both parties agree to in writing.

All provisions in the AGREEMENT and any attachments thereto in conflict with this AMENDMENT shall be and hereby are changed to conform with this AMENDMENT.

All other terms and conditions not in conflict with this AMENDMENT remain unchanged as agreed to in the original AGREEMENT.
