Mr. Roth introduced the item and noted into record the above item numbers 4, 6, 7 and 8 requiring approval of new training programs. However, he additionally noted considering the fact a quorum had not been established, the items would be considered to the Board if agreed by consensus of the members present.

Dr. Rod inquired about career center staffs' responsibilities for assessing and recommending training programs to individuals seeking training. He later shared with the Committee that he'd recently visited the Little Havana Career Center and no one knew of the various new training programs offered. Both Mr. Roth and Ms. Kavehersi responded to his concerns. He additionally commented that he doesn't feel the current operational processes at the Career Centers are effective, as he felt there is a gap between information provided internally to staff at the careers centers and the information that is actually being provided to the local communities throughout Miami-Dade and Monroe Counties regarding the programs that are available to qualified individuals. Ms. Kavehersi explained the various advertising strategies CSSF currently does to timely disseminate updated information to the communities. He went on to share with Committee that he and Assistant to Miami-Dade County Mayor, Ms. Maria Machado, have visited several centers and witnessed the communication inefficiencies. The Committee recommended better marketing through outreach.

Mr. Roth asked whether in the past, individuals had been placed in approved programs at 100% levels. Ms. Kavehersi responded, "Yes" and explained the success of the nursing program.

Ms. Kavehersi informally introduced Carlos Carrillo of ABC who briefly responded the Dr. Rod's questions and gave examples.

Mr. Clayton asked whether the Homestead Career Center is currently closed. Ms. Kavehersi responded that the center is currently undergoing restructuring.

Mr. Perez inquired about the names of employers that ABC currently partner with to place program graduates. He further asked whether there are any commitments. Mr. Carillo responded

Mr. Clayton inquired about transportation for those interested in participating in the various programs. Someone from the audience responded that bus cards are given to those individuals.
