Agenda items are displayed in the order they were discussed.

1. Call to Order

Edward Margolis, SFWIB Chair, called the meeting to order at 8:45 A.M. and noted that a quorum had not been achieved. He asked those present to introduce themselves.

3. WIA Rescission

Mr. Beasley, SFW Executive Director, presented the latest information regarding the pending rescission of funds.

He informed the Committee members that on December 26, 2007, President Bush signed into law the FY 2008 Omnibus spending bill. The amended bill included a rescission of \$250,000,000 in prior year Workforce Investment Act unexpended balances for the Youth, Adult and Dislocated Worker formula programs.

He indicated that the \$250 million dollars rescission within the FY2008 Omnibus spending bill will impact the State of Florida by \$13.75 million dollars and based on the implementation rescission instructions in US Congressional Report 110-424, the majority of the rescission will come from State's Governor reserve. AWI/WFI representatives have identified the fiscal impact to the workforce regions will range between \$1 million to \$1.5 million dollars.

Mr. Beasley reviewed and provided an email message dated January 16, 2008 sent to Regional Workforce Board (RWB) Directors, subject *WIA Rescission Update* from Jim Doyal, AWI.

The e-mail indicated that Florida's share of the nationwide rescission dropped to an estimated \$12.2M, pending tabulations to be made by USDOL.

SFW can expect to potentially have another reduction of 1.747% in funding, and another 1.747% reduction on next years funding.

Mr. Beasley noted that in a previous conference call with the State those on the call were informed that a majority of rescission funds would probably be absorbed by the State, and according to staff, following a more recent call, it would still be the case.

Mr. Marinelli said the Intergovernmental Affairs Committee would be available to help plan strategies.

4. Miami-Dade/Monroe Counties Interlocal Agreement

Mr. Beasley reported that the agenda item for the renewal of the Interlocal Agreement had been approved by the Miami-Dade County Commission. The only comment made was by Commissioner Moss who asked about the involvement of for-profit organizations.

Mr. Marinelli noted that when the Interlocal agreement was first submitted there was much conversation before it was approved.

[Joe Chi arrived.]

Mr. Marinelli offered that the information at the end of the Mayor's memo be moved to the beginning of the memo.

Mr. Beasley noted that the information was submitted to the Mayor's office.

Mr. Marinelli commented that appearing before the Commission would be good for marketing the SFW.

Mr. Beasley responded that an additional report for the mayor's office is being prepared. He added that he had met with Commissioner Sorenson and answered her questions.

He added that Deb Barsell, Monroe County, informed him that the Agreement would be included on the Monroe County Commission agenda for February.

2. Approval of Executive Committee Meeting Minutes of November 27, 2007

Mr. Margolis noted that with the arrival of Mr. Chi a quorum had been achieved and called for a motion to approve the minutes.

Mr. Margolis reported that he had had a conversation with Mayor Alvarez' assistant, Luis Gazitua regarding quorum issues and that SFW needs to solicit members from larger local companies such as: American Airlines, Florida Power and Light (FPL), AT&T, and Burger King. Mr. Marinelli added that the Members who are not attending should be replaced, but it would be unmanageable to increase the size of the Board. He agreed with Mr. Margolis that larger companies need to be represented on the board.

Fred Marinelli moved to approve the minutes of the November 27, 2007 Executive Committee meeting. The motion was seconded by Daniel Fils-Aime, Sr. and approved.

5. Career Center Evaluation Benchmarks

Mr. Beasley reported that a Workforce Systems Improvement Committee Task Force was scheduled to meet on January 25th to consider proposed Career Center designs. He distributed information collected from the Service Providers and staff. He also distributed the *Guide to Improving One-Stops through Benchmark Critical Success Factors*, which was sent to SFW by Mr. John Metcalf, Senior Partner, Corporation for a Skilled Workforce.

He asked the Members to keep in mind that there will be a rescission, and a cut in funding, and questions are asked whether staff would be impacted. At this time we fund the bricks and mortar, which has meant that we have been cutting staff. This also means that quality services would not be provided if a reduction

in staffing were to be required at this time. We need to look at ways that does not impact staffing, but impacts the brick and mortar. He offered that Career Centers should be a consolidated, not just closed.

He added that the Service Providers are being asked to do more and more with less staff, and it cannot continue in that way.

Mr. Marinelli noted that SFW may need to serve fewer customers and serve them well because SFW may not be able to be all things to all people. He added that SFW may need to fine tune our mission. His preference is not to have bricks and mortar, but would rather have programs with more people per Center and reduce the number of Centers, if necessary.

Mr. Beasley noted that there is now empty space in some of our Career Centers which would permit consolidation of Career Centers. He added that the last time this Region attempted this process, there was no buy-in from the providers and it was difficult and that's why I've asked the providers how the Career Center system should look.

Mr. Fils-Aime commented that politics is a major factor and the last time there was much conversation by local representatives of organizations and elected officials.

Mr. Beasley noted that the past SFW administration of did not get the buy-in of the Providers when decisions were made. He asks that bricks and mortar be affected by the funding reduction, and not the staff. He offered that current staff could be consolidated into fewer Career Centers.

Mr. Marinelli commented that alternative funding must be sought because of the changes to property taxes. We cannot be all things to all people. The one area that needs to be increase is job training because the economy is on a down-turn.

Mr. Andy Perez cautioned that SFW must act quickly with a plan if there is to be a consolidation of Career Centers so all Career Centers needed are staffed.

Mr. Marinelli expressed concern that consolidating sites before all funding is approved could cause confusion if additional funding were to be received. Sites might then need to be opened after having been consolidated.

Mr. Beasley noted that the creation of access points does not require funding, and a number of Miami-Dade County Commissioners have partner agencies that are interested. They would be employment access points, and the computers could be purchased with Reed Act funds. SFW can not be the be-all and end-all.

Mr. Beasley noted that the Career Centers are our major core product, but it does no good if there is insufficient staffing.

Mr. Chi asked the percentage of the budget going to bricks and mortar compared to service delivery. Mr. Beasley responded that bricks and mortar comprise approximately 13 percent of the budget.

Mr. Chi asked if the contract process could cap the brick and mortar costs. Priorities must be established, so creative ideas are necessary.

Mr. Marinelli suggested that staff look at re-negotiating some leases.

Mr. Beasley commented that sites with lower rents have been investigated. He added that SFW must get to a point that regardless of funding cuts, the services are not affected.

Mr. Margolis asked what process is in place with the Service Providers.

Mr. Beasley responded that the Providers have sent information to him, and that one-day training would be held in February. Questions to ask are: current lease expirations; optimal Career Center location; and the cost per ratio, etc.

Mr. Fils-Aime asked if the City of Hialeah had vacant sites to which the Career Centers could be relocated.

Mr. Marinelli responded that the building in which the Career Center is located is the property of another Hialeah department. He added that the savings achieved by moving into a City of Hialeah site would be negligible, even if a site were available.

Mr. Marinelli agreed that developing Access Points is a good idea.

Mr. Beasley responded that the Access Points would allow more access to services. He added that the SFW mobile units would be in some parades, are also available for other neighborhood activities.

Mr. Chi offered that he has vacant office space at his office and room for a mobile unit.

Mr. Marinelli noted that the City of Hialeah would be building a charter school that could become an Access point.

Mr. Margolis asked in regards to transportation, how often those being trained must meet with a case worker. Mr. Beasley noted that with staffing as it is he could not guarantee that staff could provide all desired services. He added that the state agencies in Miami-Dade do not own buildings. The workforce regional office in Broward County pays the state rate for their site, and we pay an average cost per square foot of \$21.

Mr. Marinelli noted that the State staff had to be absorbed into our Career Centers.

Mr. Margolis asked how many staff people are there right now in the Region. Mr. Beasley responded that he has that information. He added that the caseloads per Center must also be determined.

Mr. Fils-Aime mentioned that there are also two Career Centers in Monroe County.

Marinelli recommended that the Committee recommend a plan, and have the SFWIB approve the plan before going to the Commission. Mr. Fils-Aime responded that he was referring to the Access Points, not the location of Career Centers.

Mr. Marinelli suggested including local churches in the Region. Mr. Beasley responded that he had been contacting those organizations, and the response has been very positive.

Mr. Perez commented that given the rise in the cost of gasoline, it might be more effective to offer customers a monthly Metrorail/Bus pass at \$45 per month rather than a \$30 gas card.

Mr. Marinelli added that the City of Hialeah has four circulator busses.

6. SFW 08/09 Budget Discussion

Mr. Beasley noted that there would be a 10 percent reduction in all United States Department of Labor (USDOL) program funding and there would be an additional cut of 1.74 percent.

Mr. Beasley brought to their attention a \$5.7million difference in the budget from the last budget.

He added that the Temporary Assistance for Needy Families (TANF) caseload has decreased, and that is in part because many recipients have reached their time limits.

Mr. Beasley reported that the budget is expected be presented to the full Board in April.

BACKGROUND

The Board at its June 21, 2007, meeting approved developing in partnership with the Early Learning Coalition of Miami-Dade/Monroe (ELC), The Children's Trust and Miami-Dade County Public Schools a Career Pathway Program for Child Care Educators.

Federal Solicitations for Grant Applications (SGAs) most recently the Science, Technology, Engineering and Mathematics (STEM) application and the High Growth Job Training Initiative Grants for the Energy Industry & Construction & Skilled Trades in the Energy Industry are emphasizing the need to develop career pipelines to meet regional talent development.
