1. Call to Order and Introductions

Chairman Jeff Bridges called the meeting to order at 8:36am, asked all those present introduce themselves. Quorum achieved.

3. Information – TechHire Summer Boot Camps Update

Chairman Bridges introduced the item and Executive Director Rick Beasley presented Youth Programs Manager Tomara Graham who provided further updates.

Vice-Chairman Perez inquired about participants that wouldn't be interested in taking the exam. Mr. Beasley and Ms. Graham further explained.

Vice-Chairman Perez requested clarification on the termination of Cuban American National Council's (CNC) contract. Mr. Beasley explained.

Chairman Bridges inquired about a timeline for temporary direct services. Mr. Beasley explained.

The Council inquired about the number of centers that would be noncontract providing temporary direct services. Mr. Beasley responded, two.

There was continued discussion regarding temporary direct services, rejection of letter, cost reimbursements, and legal issues.

Ms. Ferradaz inquired about an emergency procurement.

Chairman Bridges inquired about the state's approval and its processes for this Local Workforce Development Board to provide direct services. Ms. Ferradaz explained that it's contingent to the State of Florida's approval. Mr. Beasley explained the approval processes.

Ms. Gilda Ferradaz moved the approval of SFWIB to provide direct Employment & Training Services. Motion seconded by Ms. Maria Garza; Motion Passed Unanimously

6. Recommendation as to Approval of Related Party Training Vendor Agreements Mr. Beasley introduced the item.

Ms. Ferradaz gave an update on the Food for Florida Disaster Food Assistance Program hosted by the Department of Children and Families. She thanked CSSF's partnership and especially thanked SFWIB Human Resource Manager, Teresa Serrano and HR staff for their diligent work with recruitment for this effort. She noted this agency helped recruit over 800 temporary employees within two weeks with an estimated 89% of employees that showed up to work and 97% retention rate.

Mr. Beasley thanked Department of Economic Opportunity (DEO) Manager, Yian Perrin, Adult Programs Manager David Gilbert, Adult Programs Supervisor Robert Smith for also assisting in the coordination of the recruitment process.

Mr. Beasley gave an update on the National Emergency Grant (NEG) and thanked staff for their efforts as well.
