1. CALL TO ORDER & INTRODUCTIONS Chairman Gibson called to order the regular meeting of the SFWIB Executive Committee Meeting at 8:18AM on February 12, 2026.

Agenda items are displayed in the order they were discussed.

Before the start of the meeting, Mr. Beasley conveyed the sad news of the passing of Chairman Gibson’s grandmother, Ms. Thelma Gibson. He also informed the Committee



about Mr. Joe Chi's upcoming surgery. Mr. Beasley kindly requested that the Committee keep both individuals in their thoughts and prayers during this difficult time.

2. Public Comment

Public comments should be two minutes or less.

Chairman Gibson opened the floor for comments from the public. No requests to speak were received by the Executive Office. None presented. Item closed.

3. Approval of Executive Committee Meeting Minutes – January 8, 2026

Chairman Gibson presented SFWIB Executive Committee Meeting minutes for review in advance of approval.

Motion for approval of January 8, 2026, SFWIB Executive Committee Meeting minutes by Mr. Mantilla; Mr. Chi seconded; **motion is passed without dissent.**

No further comments or suggestions were submitted by the members. Item closed.

[Mr. Chi joined the meeting.]

4. Information – Worker Adjustment and Retraining Notification Act Update

Chairman Gibson introduced the item; Mr. Beasley provided an update on filings under the Worker Adjustment and Retraining Notification (WARN) Act. He noted that two companies have submitted WARN notifications for layoffs: Ambridge, a significant player in the food industry, is laying off 66 employees, while SMBC Manubank, a subsidiary of Sumitomo Mitsui Banking Corporation, is laying off 14 employees. Mr. Beasley noted that even though the numbers are small, they still affect the local workforce. He confirmed that the team will keep monitoring the situation and will update the Committee on any mass layoffs and WARN notifications.

No further comments or suggestions were submitted. Item closed.

5. Information – Florida Legislative Update, SB 528 Manufacturing

Chairman Gibson introduced the item; Mr. Beasley provided a brief overview of the topic for discussion and handed it over to Mr. Smith for further elaboration. Senate Bill 528, effective July 1, 2026, establishes the position of Chief Manufacturing Officer within the Florida

Department of Commerce and creates the Florida Manufacturer's Workforce Development Grant Program. This new role will coordinate manufacturing strategies among state, regional, and local entities. All state and local government organizations, including local workforce boards, will be required to support the establishment of this new office, which will oversee the grant program focused on managing K-12 career awareness, work-based learning, and post-secondary alignment.

Mr. Beasley further shared that Jason Mahone, Deputy Secretary, FloridaCommerce, has been appointed as the CMO and is also leading efforts for the Opportunity Zones 2.0 project.

There was additional discussion about manufacturing opportunities with Space Coast in Florida, as well as prospects in South Florida through various Korean organizations interested in data center opportunities. Mr. Chi mentioned that a proposal may be forthcoming once the \$350 billion package is finalized in the South Korean Congress.

No comments or suggestions were submitted from the members. Item closed.

6. Information – Florida Legislative Update, HB 221 Minimum Wage Requirements

Mr. Beasley introduced the agenda item and requested Mr. Smith to provide an update on the "On-the-Job Workforce Training Act," which is set to take effect on July 1, 2026.

Mr. Smith explained the bill's key provisions, limitations, and implementation requirements. This legislation will affect internships, paid work experiences, and pre-apprenticeship programs. It includes requirements for waivers, consent, and eligibility documentation for young adults over the age of 18, as well as parental consent for minors participating in pre-apprenticeship, training, or on-the-job training (OJT) programs.

He noted that the bill aims to attract employers by reducing costs while ensuring safeguards are in place to protect youth participants.

Further discussion ensued regarding reduced wages and their impact on Florida residents, especially in areas with high living costs. It was suggested that the minimum wage should be between \$20 and \$25 to keep pace with inflation. Mr. Scott and Ms. Canales shared the measures they have implemented to attract and retain employees amidst the region's rising costs of living. Mr. Mantilla commented that small businesses might benefit from the provisions in this legislation, but larger companies may exploit them.

Mr. Beasley mentioned that Mr. Smith would send a copy of the bill to all Executive Committee members and assured everyone that CSSF staff would keep the Committee updated on developments regarding this legislation.

No further comments or suggestions were submitted by the members. Item closed.

7. Informational – Florida Legislative Update, SB 1300 and HB 325 Education and Workforce Development for Current and Former Inmates

Beasley introduced the agenda item and requested that Mr. Smith share the update on Senate Bill 1300, slated to take effect July 1, 2026. The bill aims to strengthen education and workforce reentry pathways for current and former inmates, having a strong emphasis on transportation careers and CDL programs. The bill expands workforce development funds and creates incentives for small employers to hire formerly incarcerated individuals.

Mr. Smith further reviewed the key provisions of the bill and key consideration for the board including sector strategy implications, employer engagement opportunities, and data performance alignment.

No further comments or suggestions were submitted by the members. Item closed.

8. Informational – South Dade Rural Initiative Award

Mr. Beasley introduced and presented an update on the South Dade Rural Initiative award, which runs from July 1, 2025 through June 30, 2026. The awarded funds will support workforce development activities targeted toward individuals and employers in designated rural areas of South Miami-Dade County.

Mr. Beasley advised that the award is state funded and does not require WIOA requirements. The initiative aims to address local workforce needs, reduce administrative barriers, and improve training completion and employment outcomes for residents of rural communities.

No comments or suggestions were submitted from the members. Item closed.

9. Informational – WIOA Waiver Request for Youth Program Elements

Mr. Beasley introduced and presented a request to submit a waiver to the Florida Department of Commerce to be flexible with regarding the fourteen (14) Youth Program Elements aimed at education completion, skill development, and employment. The waiver, if approved, would allow CSSF to consolidate and prioritize youth program elements within an integrated, employer-driven service delivery model, focusing on pre-apprenticeships and apprenticeships to meet labor market demands.



Mr. Beasley further emphasized the benefits of increased flexibility, faster pathways to employment, stronger employer engagement, and improved participant outcomes. An update on the waiver request will be discussed further at the next meeting.

No comments or suggestions were submitted from the members. Item closed.

10. 2026 Youth Build Grant

Chairman Gibson introduced the agenda item, and Mr. Beasley provided an update on a YouthBuild grant application from the U.S. Department of Labor. This grant aims to train participants in construction while renovating housing for low-income families and homeless individuals.

The grant opportunity has a maximum funding amount of \$1.5 million, and the application deadline is March 2nd. The YouthBuild Grant would support a 40-month program designed to expand and transition youth programs into pre-apprenticeships and registered apprenticeships.

The grant requires that participants spend at least 50% of their program time receiving educational services that could lead to either a high school diploma or a state-recognized equivalent. The remaining 40% of their time must be dedicated to workforce and skill development.

The YouthBuild program will train participants in construction while they build or significantly renovate at least one housing unit for homeless individuals, low-income families, or transitional housing for the homeless.

Mr. Beasley acknowledged the organizations partnering with CSSF on the YouthBuild Grant, which include Miami-Dade County Public Schools, M-DC Public Housing, the Department of Juvenile Justice, Habitat for Humanity, and the 10 North Group.

Additionally, he mentioned plans to work with foster care youth programs and stated that he will reach out to Ms. Ferradaz for further discussion.

No comments or suggestions were submitted from the members. Item closed.



The Executive Committee meeting ended at 9:05 am with no additional business. Staff and guests were asked to leave the call while the Executive Director held a closed session for his annual performance review.

BACKGROUND:

The FY 2026 LHHS Appropriations Act provides \$194.9 billion in non-defense discretionary funding across federal programs supporting workforce development, education, health services, and community supports. The legislation includes significant investments that directly and indirectly affect workforce system operations, participant services, and employer engagement strategies.

Key provision relevant to CSSF include:

1. \$10.4 billion for workforce development and training programs administered by the U.S. Department of Labor, including funding that supports Workforce Innovation and Opportunity Act (WIOA) programs.
2. \$285 million for the expansion of Registered Apprenticeship programs, advancing the national goal of one million active apprentices.
 - \$1.5 billion for workplace safety, wage protections, and retirement security enforcement.
3. Significant investments addressing workforce participation barriers, including \$5.5+ billion for mental health services and \$1.6 billion for State Opioid Response Grants, which support behavioral health services that can improve employment readiness and retention among job seekers.
 - \$8.9 billion for Health Resources & Services Administration (HRSA) programs, including workforce pipeline initiatives and rural health investments.

4. Continued federal support for the long-term talent pipeline through \$1.4 billion in Career and Technical Education (CTE) State Grants, \$18.4 billion for Title I education programs, and maintenance of the maximum Pell Grant award at \$7,395.

The FY 2026 federal appropriations are strategically significant to the South Florida Workforce Investment Board because they influence the overall level of national investment in workforce training and may shape future funding allocations to states and local workforce boards. The legislation places increased emphasis on registered apprenticeships, sector-based training strategies, and addressing barriers to workforce participation—priorities that closely align with regional workforce initiatives focused on employer-driven training models and reconnecting individuals facing employment barriers. For the Executive Committee, awareness of these investments is important as they may inform future grant opportunities, funding levels, and programmatic priorities affecting CareerSource South Florida operations. In particular, expanded apprenticeship funding and enhanced resources for behavioral health and substance use services may support program growth, strengthen strategic partnerships, and improve service delivery across the region.

BACKGROUND:

FloridaCommerce has released the Program Year (PY) 2025–2026 Quarter 2 Indicators of Performance for all Local Workforce Development Boards (LWDBs). CareerSource South Florida (LWDB 23) has once again demonstrated strong performance across all federally negotiated Workforce Innovation and Opportunity Act (WIOA) measures.

Summary of Results CSSF met or exceeded all 18 WIOA performance indicators for Adults, Dislocated Workers, Youth, and Wagner-Peyser programs. These results reflect continued improvement and sustained high performance across multiple program years.

Key highlights include:

- **Adult Program**
 - Employed 2nd Quarter After Exit: 83.3% (129% of goal)
 - Median Earnings 2nd Quarter: \$8,408 (123% of goal)
 - Credential Attainment: 80.5% (159% of goal)
 - Measurable Skill Gains: 91% (365% of goal)

- **Dislocated Worker Program**
 - Employed 2nd Quarter After Exit: 87.2% (112% of goal)
 - Median Earnings 2nd Quarter: \$11,759 (115% of goal)
 - Credential Attainment: 89.1% (103% of goal)

- **Youth Program**
 - Median Earnings 2nd Quarter: \$5,793 (152% of goal)
 - Credential Attainment: 70.5% (124% of goal)

- Wagner-Peyser
 - Employed 2nd Quarter After Exit: 64% (103% of goal)
 - Median Earnings 2nd Quarter: \$7,923 (130% of goal)

Overall Performance CSSF continues to rank among the strongest-performing workforce boards in Florida, with Quarter 2 results showing consistent gains compared to prior program years (PY 2021–2022 through PY 2024–2025). These outcomes reflect the effectiveness of CSSF’s service delivery model, employer engagement strategies, and training investments.

BACKGROUND:

FloridaCommerce has released the Program Year (PY) 2025–2026 Quarter 1 REACH Act Letter Grade performance results for all Local Workforce Development Boards (LWDBs). CareerSource South Florida (CSSF – LWDB 23) continues to demonstrate exceptional performance and remains the top ranked workforce board in the State of Florida.

Summary of Results CSSF earned a Quarter 1 score of 97.34, resulting in an A+ rating—the only workforce board in Florida to achieve this distinction for PY 25–26 Q1.

This continues CSSF’s multi year trend of high performance, following scores of 97.02 (PY 22), 101.7 (PY 23), and 103.27 (PY 24).

Statewide Comparison CSSF ranks #1 out of all 24 LWDBs, outperforming:

- CareerSource Southwest Florida – 93.15 (A)
- CareerSource Broward – 92.91 (A)
- CareerSource Suncoast – 91.22 (A)
- CareerSource Northeast Florida – 88.86 (B+)
- CareerSource Tampa Bay – 87.43 (B+)
- Remaining boards scoring between B and C range

CSSF is the only board to achieve an A+ rating this quarter.

CSSF Quarter 1 Performance Drivers CSSF's 97.34 score reflects strong outcomes across all REACH Act metrics, including:

- Participants with Increased Earnings: 48.88% (97.76% of target)
- Reduction in Public Assistance: 54.65% (100% of target)
- Employment & Training Outcomes: 100% (met target)
- Participants in Work Related Training: 20.99% (83.96% of target)
- Continued Repeat Business: 43.34% (100% of target)
- Year Over Year Business Penetration: 26.4% (exceeded target)
- Completion to Funding Ratio: 100% (met target)
- Serving Individuals on Public Assistance: 59.69%

These results demonstrate CSSF's continued leadership in workforce performance, business engagement, and service delivery effectiveness.

BACKGROUND:

CareerSource South Florida (CSSF) has initiated Rapid Response planning in anticipation of Amazon's temporary closure of its South Dade fulfillment facility. As outlined in the attached memorandum to Mayor Daniella Levine Cava, Amazon will shut down operations to complete a \$200 million modernization and robotics upgrade, resulting in the layoff of approximately 900 employees. Amazon has committed to rehiring a minimum of 1,000 workers when the facility reopens in 2028.

CSSF serves as the local Rapid Response coordinator for the FloridaCommerce Department, responsible for leading all reemployment, training, and employer engagement activities for impacted workers.

Update on Meeting with Mayor Levine Cava and Amazon This morning, CSSF met with Mayor Levine Cava and Amazon representatives, led by Mr. Sam Blatt, Economic Development Manager. During the meeting:

- Amazon confirmed the facility will close July 1, 2026.
- Amazon intends to submit its WARN notice on May 1, 2026.
- Amazon has contracted KAHM, a third party provider, to deliver reemployment workshops and support services to affected workers.

CSSF presented its Rapid Response and Reemployment Strategy, which includes:

- Worker orientations, WIOA eligibility screening, and case management
- Job placement assistance and résumé/interview preparation
- Access to training, apprenticeships, and supportive services
- Employer outreach supported by EconoVue labor market intelligence and Beacon Council employer mapping
- Wage reimbursement incentives of up to 100% for employers hiring displaced workers

CSSF requested that Amazon consider submitting the WARN earlier—April 1, 2026—to allow CSSF to deploy financial incentives immediately and begin matching workers to the extensive list of available job openings included in the attached report.

Mr. Blatt agreed to allow CSSF to work directly with KAHM to coordinate reemployment workshops and employment assistance.

Next Steps A follow up meeting is being scheduled for next week with:

- Commissioner Vice Chairman Kionne McGhee
- Mr. Sam Blatt (Amazon)
- CSSF leadership

This meeting will focus on employer engagement, worker outreach, and coordination with Miami Dade County departments.

Overview

This memorandum provides an update on CareerSource South Florida's (CSSF) coordinated Rapid Response and re-employment strategy in anticipation of Amazon's planned closure of its South Florida fulfillment facility. Amazon has notified CSSF that it will temporarily cease operations to undertake a \$200 million modernization project, transforming the site into a regional fulfillment center equipped with advanced robotics and infrastructure upgrades. As a result, approximately 900 employees will be laid off during the transition period. Amazon has committed to employing a minimum of 1,000 workers when the facility reopens in 2028.

As the local Rapid Response coordinator for the FloridaCommerce Department, CSSF is responsible for leading all reemployment, training, and employer engagement activities to support impacted workers and mitigate economic disruption.

Rapid Response Coordination

CSSF will activate its Rapid Response protocols immediately upon receipt of Amazon's WARN notice. The Worker Adjustment and Retraining Notification (WARN) Act requires employers to provide advance notice of mass layoffs or closures. Once a WARN is filed with the State or the Mayor's Office, affected workers become automatically eligible for CSSF-funded services, including training, apprenticeships, and wage-reimbursement incentives for employers who hire displaced workers.

CSSF will coordinate directly with FloridaCommerce, Amazon leadership, Miami-Dade County, and regional partners to ensure timely communication, worker engagement, and service delivery.

Worker Engagement and Re-Employment Services

CSSF will deploy its Rapid Response team to provide on-site and virtual orientations for affected employees. These sessions will include:

- Information on unemployment benefits and supportive services
- WIOA eligibility screening and case management
- Skills assessments and individualized employment plans
- Job placement assistance and résumé/interview preparation
- Access to training, apprenticeships, and upskilling opportunities

CSSF will prioritize workers for WIOA Adult, Dislocated Worker, and special funding streams to ensure rapid reemployment.

Employer Outreach and Hiring Strategy

CSSF will lead employer engagement efforts to identify immediate job opportunities for displaced Amazon workers. Using EconoVue labor market intelligence, Beacon Council employer mapping, and direct outreach, CSSF will target employers in logistics, warehousing, manufacturing, aviation, transportation, and related sectors.

In addition, I have spoken with Mr. JC Liscano of American Airlines, who indicated that the airline may have employment opportunities suitable for transitioning Amazon workers. These opportunities, combined with the employer list identified by the Beacon Council, will support a robust reemployment pipeline.

CSSF will also deploy wage-reimbursement incentives—up to 100 percent for eligible hires—to encourage employers to absorb displaced workers quickly.

Training and Upskilling Pathways

CSSF will offer impacted workers access to high-demand training programs, including:

- Supply chain and logistics certifications
- Advanced manufacturing and robotics training
- IT and digital skills programs
- CDL and transportation training
- Registered apprenticeships and pre-apprenticeships

Supportive services such as transportation, tools, uniforms, and exam fees will be available to eligible participants.

Long-Term Workforce Strategy for Amazon's 2028 Reopening

CSSF will maintain a talent pipeline of displaced Amazon workers interested in returning to the upgraded facility. Over the next two years, CSSF will provide ongoing upskilling aligned with Amazon's future robotics-enhanced operations.

CSSF will work with Amazon to design training pathways that prepare workers for advanced automation roles and will coordinate recruitment and hiring events as the reopening approaches.

Conclusion

CSSF is fully prepared to lead the Rapid Response and re-employment strategy for Amazon's temporary closure. Through coordinated planning, targeted employer engagement, and robust training investments, CSSF will support displaced workers while strengthening Miami-Dade County's workforce and economic resilience.

We will continue to keep your office informed as this process advances and as Amazon finalizes its WARN submission.
