1. Call to Order and Introductions

Mrs. Giles called the meeting to order at 1:42 P.M. and noted that a quorum had not been achieved.

2. Approval of Youth Council Meeting Minutes November 28, 2007

The minutes were not approved due to the lack of a quorum.

3. Request for Proposal (RFPs) Guidelines for The Children's Trust Grant Funds

Myria Morgan noted that attachment 2 contains the recommendation by staff. She added that mentoring and job shadowing had been mentioned.

There was a lot of discussion concerning:

- The need for more tutoring
- Funding for tutoring
- Ensuring exposure to career opportunities (Career awareness)
- Apprenticeships and not just the usual internships
- Career exploration such as mentoring and entrepreneurship
- How to be an effective business person
- Financial literacy

James Morrison commented that there needs to be more tutoring. Ms. Morgan responded that tutoring is in the regular plan and is provided by the school system, and that this RFP was not geared toward tutoring and it would not be a paid activity. Mr. Morrison replied that there needs to be funding for tutoring.

Mr. Beasley responded that the funds have been distributed to the providers. He added that mentoring must be career related and at the worksite.

Zahraa Younis commented that she is interning in the court system and enjoys the interaction, and the discovery of skills she did not know she had. Mr. Beasley commented that the employment opportunity allows young people to explore careers that they might not have thought of. Mr. Morrison added that he is working in the court system at the Justice Center and he has chosen that field for his major.

Mr. Beasley asked if Mr. Morrison and Ms. Younis were aware of entrepreneurships and their benefits. He referenced two young men who were mechanics, learned to work on hybrid cars, and now have their own business.

Ms. Giles recapped that at the last meeting there was much discussion on career awareness, career exploration, how to proceed with the entrepreneur piece, and how to be an effective business person.

Mr. Beasley asked if Mr. Morrison and Ms. Younis knew how to reconcile their checking accounts, and whether they had been to workshops on that as well as how to read and interpret the stock market information.

[Mr. Margolis arrived.]

Mr. Margolis noted that the goal is to improve communication and to develop a well prepared workforce for local industry.

Mr. Beasley distributed two reports: "Fastest Growing Occupations" and "Occupations Gaining the Most New Jobs" (both sources: Florida Agency for Workforce Innovation, Labor Market Statistics Center-September 2007).

Ms. Giles added that agricultural careers should be investigated. Mr. Beasley commented on land-grant institutions, and the types of occupations, and that the USDA has scholarships.

Mr. Margolis brought up the proposed tunnel to the seaport to assist trucks delivering goods to the seaport, and he suggested that the younger members might be able to come up with a solution, to get the truck traffic to the airport more efficiently. That would increase the income to Miami-Dade County.

Mr. Beasley commented that the Youth Council report to the Board would focus on the action item to accept the Children's Trust funds, as well as the RFP.

Ms. Giles thanked the Committee for their comments that would assist staff in preparing the Request for Proposals (RFP).

Ms. Younis offered a comment that there is some difficulty using the PCs at the Career Centers because the computers are sloe, and some sites are blocked, although they may be educational.

Mr. Morrison noted that those "Out of School" youth receive only \$30 in a gas card, and the cost of gasoline is increasing, and asked if the amount could be increased.

Mr. Beasley commented that if the amount is increased, then SFW could then help fewer youth. There followed discussion concerning the benefits of using the bus pass.

Ms. Giles thanked the members and the meeting adjourned at 2:35 P.M.
