Young Adult Summer Career Pathway Compact Initiative Update

Information Item

BACKGROUND

At the Board's February 16, 2012, meeting, the Board approved allocating up to \$1,498,956 million dollars to support the 2012 Summer Young Adult Career Pathway Compact Initiative.

The program is coordinated through the One Stop Career Centers. This initiative provides pathways to employment for low income and disconnected young adults. Approximately 690 young adults are expected to be placed with employers in Miami-Dade and Monroe counties. To participate in the summer program, employers and young adults are required to register on-line at the SFWIB website. The registration process began as of March 9, 2012.

Approval to Renew Contracts of Existing Youth Services Providers

RECOMMENDATION

SFWIB staff recommends that the Youth Council recommend to the Board the approval to renew the current youth service provider contracts for the next program year, July 1, 2012 to June 30, 2013.

BACKGROUND

As a result of the February 2011 procurement process, the current youth service providers were competitively awarded to deliver youth services in Region 23 for Program Year July 1, 2011 through June 30, 2012. The current contracts for youth service providers end on June 30, 2012. However, the contract contains language affording the option to continue the delivery of youth services for an additional program year (July 1, 2012 to June 30, 2013).
